Applications are hereby invited from eligible Agencies / Organisations / Firms for appointment as Implementing Agencies to undertake Processing, Packaging, Transportation, Logistics, Distribution and Fund arrangements for payment to CNAs for the products under the PSF scheme in Arunachal Pradesh 3 years. The application and other relevant documents may be submitted to the office of the CEO, Arunachal Pradesh Agriculture Marketing Board (APAMB), Krishi Bhawan, Naharlagun, Arunachal Pradesh on or before 1600 hrs of 29th Nov. 2024.

1. Eligibility of such agency/firm:

- 1.1. Should have enacted processing, milling and packaging for products for any government of India, State or any UT and state autonomous councils.
- 1.2. Should have net worth of minimum Rs 100.00 crores in last 3 FYs or shall submit bank guarantee of Rs.10 crores for the whole of execution period.
- 1.3. Any Agency/ Organisation/ Firm having been empanelled as an Implementing Agency under the particular PSF scheme by any State, UT or Autonomous council under the union government of India is exempted from clause 1.2 above.
- 1.4. Joint Venture/Consortium/Power of Attorney and sub-contract shall not qualify.

Applicants may note that the scheme does not involve any financial obligation of the State or the Union government of India, in whatsoever capacity or engagement.
