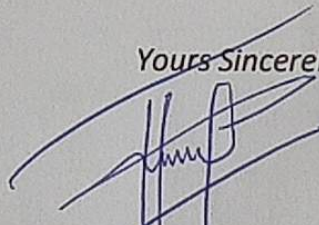

1. Tender documents can be seen / purchased in person from the office of the Executive Engineer, Water Resources Division, Likabali on any working day **between 11.00 A.M to 4.00 P.M from 09/12/2024 (Monday) onwards** against payment of Cost (Non- Refundable) of tender documents shown above against each package in cash / demand draft / receipt Treasury challan in favour of the Executive Engineer, WRD, Likabali payable at SBI Likabali/Any Branch of the state or Nationalised Bank from **09/12/2024 (Monday) to 16/09/2024 (Monday)** on any working days except on Sunday and public holidays.

2. The Tender shall be submitted in two bids viz Technical Bid and Price Bid. Each of the Bids shall be placed sealed in separate cover and submitted within stipulated time.

3. The Technical Bid Will be Open first and evaluated to assess Technical and Financial capability of the contractor and their work experience. Based on such evaluation and after adopting the post qualification procedure the price bid containing schedule of quantities shall be open for further evaluation.

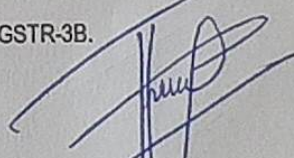
4. **The Bidder should mandatorily obtain NOC from the land Donor/Field Owner/Farm Owner for execution of Work. Tender paper shall be issued only on submission of NOC from land Owner also preference will be given to Land Owner of the proposed site.**

5. The Payment is subjected to availability of fund and sanction by the Government. The Bidder will have no claim for losses incurred if any due to delay in funding by the Government. Self Declaration on the part of bidder shall be part of the contract agreement.

6. The Bidder has to visit the work site prior to participation of the tender, land Acquisition, Compensation and local problem if any at the sole responsibility of the bidder. Self Declaration on the part of bidder shall be part of the contract agreement.

7. The Earnest Money Deposit (EMD) should be Deposited to any schedule Bank and receipt of DDR / Demand draft of a scheduled bank guaranteed by the Reserve Bank of India issued in favour Executive Engineer, Water Resources Division, Likabali, Lower Siang should accompany the Tender Documents. The EMD must be properly sealed and signed in a separate envelope and put inside the main envelope containing envelopes of Technical and Price Bid. Bid Without accompany of EMD shall be summarily rejected.

8. Tender Paper Shall be issued on Production of Firm Enlistment, Adhaar Card, GST Registration Certificate and GSTR-3B.
