NOTICE INVITING TENDER

The Deputy Commissioner, Lower Siang District, Likabali invites sealed Tenders (**TECHNICAL BIDDING ONLY**) from the interested and financially sound registered Cooperative Societies & Lamps of the Lower Siang District and on non-participation of Tenderers from District, the nearby Districts namely East Siang District and Lepa-Rada District duly registered under the Arunachal Pradesh Cooperative Societies Act, 1978 for appointment of District Public Distribution System (PDS) Land Route Carriage Contractor (**RICE ONLY**) in respect of Lower Siang District for the year **2025-26 & 2026-27** for deposits, procurement, drawal, lifting and transportation of Rice under Public Distribution System from designated FCI base depot Pasighat or any other designated FCI base depot notified by the Govt. from time to time and its further delivery to various en-route & off-route FPS locations in the district.

1. At first instant, interested Registered Cooperative Society, registered under the Arunachal Pradesh Societies Registrations Act, 1978 located its business activities in the Lower Siang District of Arunachal Pradesh and on non participation of Tenderers' from district, the nearby Districts namely East Siang District/Lepa-Rada District, Arunachal Pradesh on failed/not qualified/acceptable as per terms and conditions of the tender.
2. At second instant from interested Registered Society (NGO's) registered under the Arunachal Pradesh Societies Registrations Act, 1978 located its social activities in Lower Siang District of Arunachal Pradesh, and on non participation of Tenderers from District, the nearby Districts namely East Siang District/Lepa-Rada District (AP) on failed/not qualified/acceptable as per terms and conditions of the tender.
3. At Third instant from interested individual/business person of this District and on non participation of Tenderers from District, the nearby Districts name East Siang District /Lepa-Rada District (AP).

The tender papers with details terms & conditions of the tender can be obtained from the office of the District Food & Civil Supply Officer, Likabali during office working hours from **27-12-2024 to 10-01-2025** on depositing of **Rs. 5,000/- (Rupees Five thousand)** only in form of Treasury Challan under Head of Account **1456 Food & Civil Supplies** (Non - Refundable).

The Sealed Tenders papers may be deposited in the respective sealed Tender Boxes at the Office of the District Food & Civil Supply Officer, Likabali during office working hours from **13-01-2025 (Monday) to 17-01-2025 (Friday)** up to **1300 hours** and will be opened on the same day at **1500 hours** at DC's Conference Hall, Likabali by the Board of Officers in presence of intending tenderers.

There shall be set-up 04 (four) nos. of Tender Boxes (i) For the Tenders of Cooperative Societies/Lamps of Lower Siang District (ii) For the Tenders of Cooperative Societies/Lamps of Lepa-Rada & Siang Districts (iii) For NGO's and (iv) For Local individual/business persons.

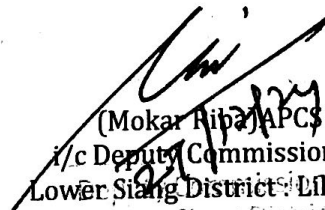
The sealed tenders in respect of clause 2 of Registered Co-operative Societies/LAMPS of adjacent Districts/NGOs shall be opened and taken up for process by the Board of Officers, if there is no valid tender found from Registered Co-operative Societies/LAMPS of Lower Siang District and otherwise tender in this respect should be treated as stand terminated and the tender paper will be returned to the respective Tenderer. Further, the sealed tender in respect of clause 3 of local individual/business person will be opened and taken up for process only if there is no valid tender (s) found from Registered Co-operative Societies, LAMPS, NGOs and otherwise the tender in this respect should be treated as stand terminated and the tender paper will be returned back to the respective Tenderer(s).
