ELIGIBILITY CRITERIA

The applicant (s) of the above post should invariably be person of eminence in the public life or in the field of Higher Education or who have remained Secretary or above to the Government of Arunachal Pradesh or held equivalent posts in the Government of India (GoI) for a period of not less than 3 (three) years. The Chairperson and Members shall not be from the same field of specialization as mandated explicitly in the **Section 4, Sub-Section (1) of "Arunachal Pradesh Private Educational Institutions (Regulatory Commission) Act, 2017"**.

TERMS & CONDITIONS

The Member of the Commission shall be appointed by the State Government on the recommendations of a Search Committee for a period of 3 (three) years or until he or she attains the age of 65 years, whichever is earlier, and such Member may be eligible for a second term subject to the upper age limit of 65 years. After the expiry of the term of office, the Member, as the case may be, shall not be eligible for further employment or any assignment in any of the Private Educational Institutions within Arunachal Pradesh or their associate offices or Companies within or outside Arunachal Pradesh for a period of three years as mandated explicitly in the **Section 4, Sub-Section (2) of "Arunachal Pradesh Private Educational Institutions (Regulatory Commission) Act, 2017"**
