1. The earnest money in the form of FDR/STDR of nationalized bank/Scheduled Bank should be deposited along with the tenders in the appropriate form as per the tender documents. The tender documents shall be issued **on production of valid registration certificate of appropriate class** and on payment by cash **as mentioned in column - 6** for being the cost of tender documents (non-refundable) as shown above against the work.

2. The earnest money **1% for APST** should be submitted in the form of DD/FDR/STDR nationalized bank/Scheduled Bank in favour of **The PROJECT DIRECTOR, RD, CHANGLANG payable** at Any Govt. recognized Bank in Changlang.

3. Tender documents will be issued *as per Govt. Notification vide No. SPWD/W-66/2012 Dtd 13th August 2015 (Amendment act. 2020) (Act, No.7 of 2020) vide. No. Law/Legn-23/2020. Dated 2nd November 2020* and modified time to time to eligible contractors provided they produce the valid original contractor registration from the appropriate Authority and **NOC issued from the Managing Director, Co-op Apex Bank Naharlagun (the certificate being not more than six (6) months old)**. The bidder must produce permanent residential certificate, S.T. certificate, and contractor registration certificate for issuance of bid.

6. It is compulsory for the Bidder, at his own cost, responsibility, and risk, to visit, examine and finalized himself with the site of works and its surroundings including source of principal materials, overheads, probable local problems etc before submitting the bid.

7. **Availability of Bid Document and mode of submission:** The bid document is available in the **PD (RD) Office Changlang** from 24-03-2025 to 26-03-2025 during office hours on all working day and bid should be submitted to the **office of the PD (RD) Changlang, Changlang District (A.P.)** Date of submission on 26-03-2025 up to 1600 hours in one Big envelope consisting of three separate envelopes system 1st envelope consisting of document related to earnest money ,2. Technical bid and 3. Envelope containing financial bid. The bids to be inserted in a main envelope sealed with wax seal (Outer envelope).

8. The site for the work is available.

9. The bids will be opened *as per List of importance Dates of Bids in the Office of the PROJECT DIRECTOR, RD PD (RD) , Changlang District. (A.P)* if the office happens to be closed due to strike or holydays on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

10. The bid for the work shall remain valid for acceptance for a period of **90 (Ninety)** days from the date of submission of bids. If any bidder/tenderer withdraws their bid before the said period, then the earnest money shall stand forfeited.

11. Bidders may bid for maximum of three bids as per Arunachal Pradesh District based entrepreneurs and professions vide No. *SRWD/W-66/2012 Dtd 13th August 2015 clause 4(II)E (Amendment act. 2020) (Act, No.7 of 2020) vide. No. Law/Legn-23/2020. Dated 2nd November 2020* to qualify for a work of contracts made up of this and other contracts for which bids are invited in the same SBD, the bidder must demonstrate having experience and resources sufficient to meet the aggregate of the qualifying criteria for the individual contracts.

12. A bidder shall not be permitted to bid for works in the Circle responsible for award and execution of contracts in which his or her spouse's near relative (defined as first blood relations, and their spouses) is posted as Divisional Accountant or as an officer in any capacity between the grades of Joint Director (RE).

13. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a Contractor for a period of two years after his retirement from Government service, without Government permission. This contract is liable to be cancelled if either the Contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government as aforesaid before submission of the tender or engagement in the Contractor's service.

14. The bidders must submit the following documents in original with their bids viz. (a) Affidavits (b) Under taking (c) Bank Certificate for over draft or credit facilities (d) Power of attorney etc. as stated in the SBD, failing which the bids shall be declared non-responsive.

15. The bidders should demonstrate the original documents at the time of bid opening.

It is also essential for the bidder to attend Pre-Bid meeting, but non-attendance at the pre-bid meeting will not be a cause for disqualification of a bidder

16. Other details can be seen in the bidding documents. The undersigned reserve the right to accept or reject any Bid or all tender without assigning any reasons thereof.
