ORDER

Whereas, Several instances have been brought to the notice of the State Government wherein Government employees and private individuals are representing themselves as Advisors and Officers on Special Duty (OSDs) to Hon'ble Ministers, Hon'ble Advisors and Hon'ble MLAs.

Whereas, in reference to the 'GUIDELINES FOR APPOINTMENT OF PRINCIPAL ADVISOR, ADVISOR, OSD etc. TO HON'BLE CHIEF MINISTER, ADVISOR AND OSD TO HON'BLE DEPUTY CHIEF MINISTER AND OSDs TO HON'BLE MINISTERS, 2024' notified by the Government of Arunachal Pradesh vide No.CAB/G-13/06/2024 dated 19th June 2024:

- a. The number of OSD to the Hon'ble Ministers is restricted to 1(one) either from amongst serving or retired Government employees of the Department concerned or selected/recommended from outside the Government Department. A list of OSDs to Hon'ble Ministers who have been appointed by the State Government as on date of issuance of this advisory is placed as Annexure I.
- b. It is hereby clarified that **NO** individual, either Government employees or private individuals, other than individuals mentioned in **Annexure I**, have been appointed by the State Government as OSDs to Hon'ble Ministers.
- c. It is further clarified that the State Government has **not** appointed any individuals as PROs to Hon'ble Ministers, and as OSDs or PROs to Hon'ble Advisors and Hon'ble MLAs as per the above guidelines.

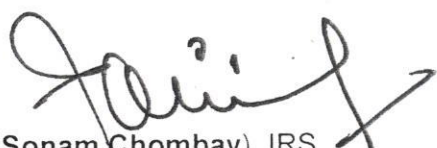
Now, therefore, the general public and Government servants are advised to exercise and maintain due caution in this regard. Further, Government servants are requested to maintain due decorum and scrupulously adhere to instructions issued by the Department of Administrative Reforms for official dealings between the Administration and Members of Parliament and State Legislatures.
