Sealed tenders in 2-bid system are invited from competent, experienced and local travel agencies based in the Itanagar Capital Region (ICR) for supply of Light Motor Vehicle (Fortuner/Innova Crysta/ Mahendra Scorpio/ Bolero) on daily/monthly rental basis for the Arunachal Pradesh State Health Society under National Health Mission (NHM), Govt. of AP, Naharlagun, initially for the period up to 31/03/2026, extendable by one year at a time subject to continuation of NHM programme, availability of fund and performance of the Vendor.

Interested and eligible bidders may submit their bids superscribed **"TENDER FOR HIRING OF VEHICLES"** to the undersigned.

The eligibility criteria and parameters for technical bid shall be as follows:

1. The Bidder must have tours & travels plying permit /registration certificate for the entire area of Arunachal Pradesh & beyond.
2. The Bidder must have its office located in Itanagar Capital Region.
3. The Bidder must possess valid and updated trading license and GST registration certificate.
4. The Bidder must have prior experience in the field for at least 5 years with average annual turnover of not less than Rs. 1.50 crore during the last 3 (three) years.
5. Turnover Certificate with 26ASITR and Balance sheet with IT returns of the last three years, duly certified by a Chartered Accountant, must be produced in the bid.
6. Copies of contract/ work order issued to the Bidder during the last 3 (three) years of last three years by at least 3 (three) Govt. departments/PSUs/ banks/ private organizations etc. must be submitted in the bid.
7. The Bidder must have in its possession not less than 8 (eight) numbers of premium category vehicles duly registered in the name of the firm exclusively for commercial purpose which must be free from parallel contract with other clients.

The financial bid shall be submitted in the following manner:

1. The rate must be quoted separately for daily and monthly basis and must be inclusive of the expenses on driver, fuel and repair & maintenance.
2. The rate quoted must also be inclusive of all admissible taxes.
