- Tender paper shall be received upto to **1200hrs on 29/03/2026** at the **office of the Executive Engineer, Chayangtajo Division, PWD, AP, Camp-Office Seppa** and shall be opened on the same day at **1400hrs and 1500 Hrs** in presence of intending contractors or their authorized representatives.
- The earnest money should be deposited to any of the scheduled Banks and receipt of Treasury Challan / Deposit at Call Receipt of scheduled bank / Fix Deposited Receipt of a scheduled bank / Demand Draft of a scheduled bank guaranteed by the Reserve Bank of India issued in favour of **the Executive Engineer, Chayangtajo Division, PWD, AP, Chayangtajo. payable at State Bank of India, Seppa Branch (Code: - 5738)** should accompany the Tender Documents.
- The Tender without earnest money shall be **summarily rejected**.
- The undersigned **reserves the right to reject any or all the Tender** without assigning any reasons.
- Tender paper shall be issued only on production of the necessary certificate in support of desired class of contractors.
- Once tender paper issued in favour of particular name/Firm shall not be changed in any circumstances.
- The Estimated Cost put to tender based on APSR 2023 (R&B) and (Bldg.).
- In the larger interest of the public and for equitable distribution of development works, a contractor shall be allowed to have only 2 (two) works in hand in any of development under government of Arunachal Pradesh at a time and for which he shall make a declaration to be executed in an affidavit that he is not engaged in more than two any tenders work under the state government. Shall also for participation in any tender be required to submit completion certificate issued by the Engineer-in-charge duly counter signed by the concerned Superintending Engineer and Chief Engineer.
- The APST contractor shall submit ST certificate to avail relaxation of earnest money in favour of them. Original ST Certificate should be produced at the time of opening of the Tender. No relaxation shall be admissible without submission of ST certificate.
- Payment shall be made as per Availability of Fund & LOC.
- Other details of NIT & eligibility criteria can be seen from bid document.
- Award of work and incur of expenditure against the work will be subjected to accord of AA & ES from the competent authority.
