 - Price list of available horticulture saplings
 - Valid GST Registration
 - Bank account number supported by a cancelled cheque leaf.
 - Pan card and Adhar card.
 - GST clearance certificate
- The proposal should reach the office of the DHO East Siang District Pasighat on or before 18th June 2026 at 1600hrs and no documents shall be entertained after due date and time.
 - Preference for selection of the firms shall be given to the Local Entrepreneurs of East Siang District.
 - The documents will be Scrutinize by the Board approved by the Deputy Commissioner, East Siang District (A.P)
 - The authentic companies/firms/service /providers/Vendors/Nurseries etc will be recommended by the approved Board, followed by approval of the Deputy Commissioner East Siang District, Pasighat. The recommended and approved Nurseries shall qualify for supply of nursery items to the Department/Beneficiary.
 - The nursery firm, approved by the Board will have no claim over supply order as the process is an exercise for screening and scrutinizing of the genuine Nursery documents only. The Board approved by Deputy Commissioner has the right to reject the applications, if the required documents are not fulfilled.
